Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 14 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 9 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

Sl. No.	CONDITIONS FOR COMPLIANCE

1	The total number of section of the school shall be restricted to 14 on the basis of running sections reported by IC. The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed. Further, increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft.
2	As per IC report there is no composite lab for secondary level. The school is directed to setup lab for secondary level as per SoPs given by the Board and submit the compliance in SARAS portal within next 3 months.
3	As per IC report the school has not appointed Special Educator and Counsellor & Wellness Teacher. The school is directed to appoint Special Educator and Counsellor & Wellness Teacher as per norms and submit the compliance within next 3 months.
4	As per IC report the library is undersized. It is also seen as under stocked with insufficient seating space for students and separate reading space for teachers. Hence the school is directed to shift the library is room size of at least 112 sqm (1200 sqft) , upgrade it as per soP issued by the Board and submit the compliance in SARAS portal within next 3 months.
5	The ramp/lift to access upper floor is not seen in the IC video. Hence, the school is directed to construct the ramp/lift to access upper floor and submit the compliance within next 3 months.
6	As per IC report, the school is having CWSN toilet two each for boys and girls but only one CWSN toilet for boys is seen in the videography. The school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
7	The school has not created mandatory public disclosure link on the home page of its website. The separate mandatory public disclosure link provided by the school is not functional. The school shall make it functional within a week and submit compliance on SARAS.
8	The front portion of the boundary wall of the school is topped with grills, which is not as per affiliation bye laws. The school shall construct a concrete boundary wall of prescribed 6ft height on the front side of the school within 3 months and submit compliance on SARAS.
9	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.

The above is subject to fulfillment of the following conditions or as may be laid down by the Board from time to time:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will strictly adhere to all rules regarding safety of students including Fire fighting and Transportation, etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students and renew all safety certificate as and when due.
3. The approval is subject to final outcome of any pending legal case/ litigation and any other issues arising out of it and Board shall not be responsible for any dispute/legal issue arising out .
4. The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye Laws.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.
